We are excited to welcome you all to the 2017 school year. The teachers have been working over the last couple of weeks preparing and planning Term One and the programmes are looking very engaging.

As always at the beginning of the year there is a little bit of administration to get through. This year we are aiming to be totally paper free - this means all notices will be emailed or placed on the school or hub blogs.

All permission forms will be made on google forms - we understand that this will take some time for everyone to get used to so we intend to run a couple of workshops on Wednesday mornings in the staffroom. The first one will be next Wednesday 1 Feb at 9.10am. The topic

Google Forms. In the meantime we will have a computer available and help on hand at school in the office should you need to use it to complete your forms.

### **Education Outside the Classroom (EOTC)**

At our school, parents complete a blanket permission form at enrolment or at the start of each year, which covers almost all lower risk activities and some higher risk activities.

The level of information provided to parents and requested from parents about EOTC activities is proportionate to the level of risk associated with the activity.

Separate parental consent is required for most higher risk activities and we ask for this on a case-by-case basis. Parents must submit a consent form before their child/children can participate. For certain activities, we will also notify parents about any risks we have identified.

### **Publishing Information Consent Form**

Images of our students (photographs, video clips, etc) and examples of their school work, are sometimes published in our newsletters, on our school website, and other online channels such as the school/class blogs, Facebook page, youTube, etc.

The purposes of publishing student material are to educate our students according to the national curriculum, to encourage students to participate in our school community, and to promote the school.

We believe it is important to celebrate students' achievements, but are aware of the potential risks when such personal information or material is published on a global information system such as the internet.

In the interest of safety and security we require parents to give permission for their child's first name, image, or work to be made public.

With consent we will share no more than a student's first name, image, or work in the school newsletter, on the school website, or in the wider community.
